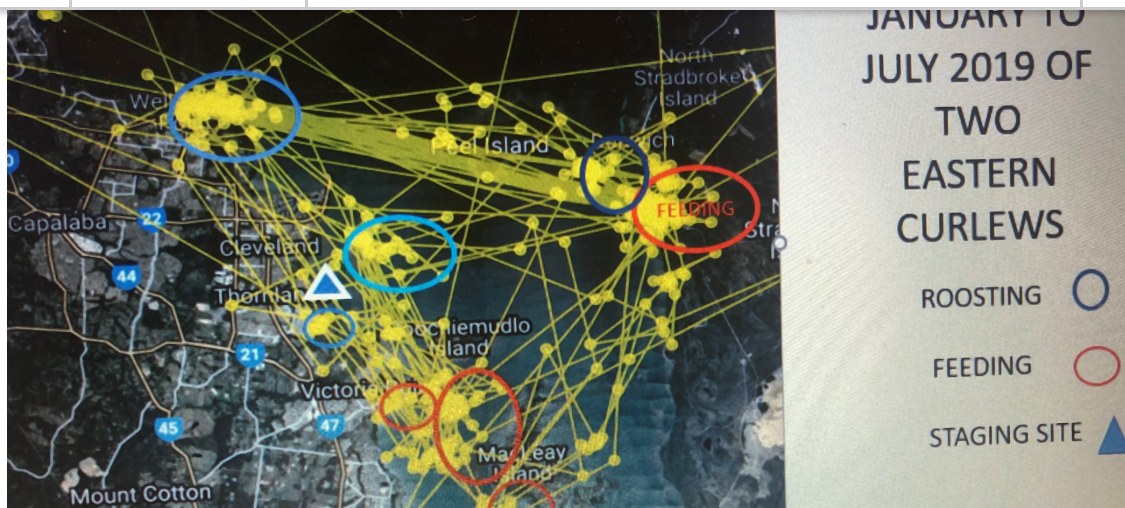


During the evening, Honorary Life Membership was bestowed on renowned coastal engineer, Dr Michael Gourlay in recognition of his significant contribution to the understanding of shoreline processes on Coochiemudlo. For over 30 years Michael has monitored sand movement around the island and more recently shared his findings as a member of the Community Reference Group for the island's Shoreline Erosion Management Plan endorsed by Council in February.



Another local hero, Olive Walters was presented with the inaugural “Coastcarer of the Year award” for her outstanding contribution to bush regeneration on Coochiemudlo. Olive, a recognised island authority on all things botanical, gives generously to the care of the island’s environment.

Guest speaker, Dr Robert Bush, member of the Australasian Wader Study Group Board, Queensland Wader Study Group Management Committee and recent past secretary of the Queensland Ornithological Society shared fascinating tracking data on the movement of migratory shorebirds around the Bay and Coochie, in particular. Coastcare will provide a link to his presentation in the next week; “Tracking Shorebirds tells us how they live and survive in Moreton Bay: There has never been a more important time to use this information to support conservation of the Bay”.

[Funding grant for survey and valuation of significant trees](#)

Coastcare is pleased to confirm a \$2,500 funding grant from Healthy Land and Water to engage a specialist consultant arborist to survey and value significant foreshore trees around the Emerald Fringe.

Priority work includes at-risk veteran trees along the eastern foreshore that will augment the recommendations of the Shoreline Erosion Management Plan for immediate beach replenishment “to repair remnant existing erosion on Norfolk Beach and return the beaches to functional units.”

Council “retires” Coochiemudlo Island’s Land Management Plan

Redland City Council voted to remove Coochiemudlo's 2004 Land Management Plan from its Corporate Register at its General Meeting on Wednesday 16 June.

The Plan, which detailed practical actions for conserving and enhancing the values of the island’s reserve land was developed in close consultation with community and official stakeholders over many months, then ratified by Council and the Minister for Natural Resources. Fondly referred to as “The Bible”, by many, the Plan was removed because Council officers deemed it no longer current. This time there was no community consultation, nor response to Coastcare calls for a review.

Sincere thanks to Councillors Lance Hewlett and Paul Bishop who spoke against the motion while other Councillors sought assurance 29 plans and strategies to be retired would be retained as background reports. Cr Hewlett said no officer had ever discussed with him how the 2010 Conservation Management Strategy could replace such a detailed island Plan, as Coochiemudlo’s which he still referenced.

“Why does Coochiemudlo Island need a LMP? To protect the existing environmental, recreation, sporting, physical, social, indigenous and European heritage values of reserve land. Council and community are working together to see the Emerald Fringe protected and to ensure public open space around the entire perimeter of the island.” **RCC Newsletter June 2004**

The same Council meeting later endorsed a new Land Management Plan for the city facilitating the use of Main Beach East as a site for **Temporary Commercial Use of Public Open Space**. Council’s original proposal was scaled down due to public response with Foreshore West removed and Foreshore East amended to allow only one secondary use, seeing continuation of the existing boat hire business. In November 2020, Coastcare lodged feedback with Redland City Council on the proposed Draft Land Management plan for the Temporary Commercial Use of Public Open Space. We objected to the proposal as we believed it was environmentally unsustainable to site four commercial operations between Flinders (Outriggers Beach) to west of the barge ramp.
